THEREFORE, the undersigned, for good and valuable consideration, the receipt and sufficiency of which being hereby acknowledged, do hereby, on behalf of themselves and their respective heirs, personal representatives, guardians, successors and assigns, release, forever discharge and hold harmless, VNTB and its Council, Council Members, Team Members, volunteers, representatives, agents, successors and assigns, including, but not limited to, the entities and/or individuals that in any way own, manage, control, maintain or reside on the premises, real property, building and facilities on which the encounter occurs, from any and all claims, demands, injuries, damages or losses of any kind or nature whatsoever, whether known or unknown, that occur either directly or indirectly from and through the weekend encounter and any and all previous, subsequent and related activities.
